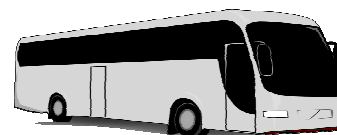

WHEN FREE ISN'T REALLY FREE:

BEWARE OF FREE TRIAL OFFERS

We've all been there. While browsing online, you see an ad for a product or subscription service with a free trial and think "Why not?"

Here's why not: What appears to be a free or low cost trial can add up to be much more. Most free trials require consumers to enter their card information to either pay for shipping or to cover future costs if the individual forgets to end the trial or subscription.

While it is easy for cardholders to convince themselves they'll remember to cancel the service before any fees hit their cards, it's not always so simple. Some deceitful businesses hide the terms and conditions of their offers in a small font or use pre-checked sign-up boxes as the default setting.

What does this mean for you? Most often, there's limitations on the charge back rights for these purchases. As your financial institution, we might not be able to claim fraud and will need to pursue charge backs through non-fraud reasons, such as "merchandise not as described" which usually offers a lower chance of success.
